Council's report card... money well spent

Let's face it. Everyone likes to know where their money goes. And frankly, that's a good thing.

Knox Council prides itself on transparent financial planning and reporting, most especially important in the case of the infrastructure levy

combined with last year's rates.

In simple dollar terms, the collection of that amount of money totals \$1,096,000 for 2007/08. But what makes it especially important is that the funds have been put to good use.

Vital community facilities that would not otherwise be constructed, have been made possible by the infrastructure levy.

Such projects have included footpaths — including Tulip Crescent (Stonehaven Av/Boronia Rd), Stonehaven Av (Woodvale/Cypress) and Boronia Road (Mountain Highway to Thaxted Parade); a shared path for Wellington Road, Rowville; several road surface renewals; street tree replacements; Bayswater Shopping Centre Public Toilet; Lewis Road Reserve toilet block; Dorset Square Shopping Centre toilet and waste management facility; and Alpine Street toilets in Ferntree Gully.

Council will continue to use this levy wisely over a three-year period, providing roads, footpaths, toilets and more. And we'll keep the community informed on just how that money is spent.
